## 1.0 INTRODUCTION

**Aswasana College of Rehabilitation Science**, established at Brundabati Bhaban, Near Bharat Petrol Pump, Nuapada of Chhendipada Block, Angul has been established by “Ability Foundation” Registered under Indian Trust ACT 1882 . The main objective of the College is to undertake Manpower Development, Provide KG to PG level of education to the Divyangjan and Create Special Educators in the field of Hearing Impairment and ASD and also provide service to the persons with Different Abled (Divyangjan).

The course prepares the Trainees to work as a Special Educators in Special Schools exclusive for Hearing Impaired Students, in Special Class situation in Regular Schools, in Inclusive set up, in Integrated set up and also to work as teacher in general school.

## 2.0 OBJECTIVES

To prepare teachers who can perform the following after completion of the course:-

- ➔ To perceive the so called ‘Disabled’ as ‘Differently Abled’ and develop in them the confidence about their potentialities, abilities and usefulness to serve the society with a sense of freedom, self-respect and dignity.
- ➔ To develop professional competencies to educate persons with Hearing Impairment & Visual Impairment.
- ➔ To know and understand various methods and approaches of organizing education of children with Hearing Impairment & Visual Impairment under inclusive, integrated and special education set up.
- ➔ To understand the nature of children with Hearing Impairment & Visual Impairment in the teaching learning process.
- ➔ To develop competencies to deal with the academic and personal problems of the learners with Hearing Impairment & Visual Impairment.
- ➔ To know and understand the various methods and techniques of evaluation and their applications.
- ➔ To develop competencies to organize various co-curricular and extracurricular activities.
- ➔ To know, understand and develop the ability to manage a Special School as well as general school.

## 3.0 ELIGIBILITY

The candidate must fulfill the eligibility conditions given below :-

- 3.1** The candidate must have passed Graduation / +3 Examination in 10+2+3 parton in Arts / Commerce /Science / B.Tech or its equivalent examination for **B.Ed.Spl.Ed.** (the candidates shall have to submit equivalent certificate from the competent authority at the time of submission of

application) with a minimum of 50% of marks in aggregate in case of General candidates and 45% of mark in aggregate in case of SC, ST, and PH candidates excluding marks secured in fourth optional / extra optional.(As per State Govt. Rules)\

**3.2 The age limit** : There is NO age limits for seeking of this RCI courses.

### **3.3 CASTE CERTIFICATE :**

In case of SC, ST candidates, the Caste Certificate should be issued by the concerned Tahasildar / Additional Tahasildar. The Caste Certificate shall be considered by virtue of birth only not by marriage or adoption.

**3.4** The candidates are required to submit PH Certificate issued in their favour in the prescribed System Generated form by Medical Board countersigned by CDMO concerned.(Reservation under PH category is for candidates with mild disability in one lower/upper limb only).

### **4.0 DURATION**

The duration of the B.Ed.Spl.Ed.(HI) programme is 2 (Two) academic years ( Four Semesters).

### **5.0 SELECTION**

The selection will be made on the basis of total marks secured /Entrance Examination / personal interview with State Govt. Reservation Polices.

### **6.0 JOINING AND SUBMISSION OF CERTIFICATES**

This is a full time course of two academic years; the candidates admitted to the Course can not pursue any other course. Selected candidates should join the course by the stipulated date.

*At the time of Admission / joining the course, the selected candidate will deposit their original certificates (10<sup>th</sup> Board & Mark sheet of Graduation or its equivalent) which will be released after the Semester- 4<sup>th</sup> Form fill up or Clearance of all dues which ever is earlier.*

## 8.0 Course Opportunities :

The trainees who shall successfully completed the Special Education course may be engaged as a special educator in various special schools / General Schools / Inclusive Set Up through out the Nation and abroad. Eligible for applying SSA , BRT , BRP , DDRC, SIEP, DAV School or any departmental special educator jobs.

## 9.0 Certificate Awarded

After Successfully completed the Course the candidates have awarded as **B.Ed.Spl. Ed.(Hearing Impairment) as a Special Educator in specified stream** by the Utkal University, Vani Vihar, Bhubaneswar.

### Note :

- *The Candidate once admitted in the course will not be allowed to leave the course under any circumstances. If the candidate still desires to leave the course by any personal reason, the total course fee will have to pay by the student and then He/ She can apply for his/her TC with Original Certificates deposited at the time of Admission and deposits paid by the candidate will be forfeited.*
- *Original Certificates deposited will not be released before full payment of the course fee and students are advised to keep sufficient number of photo copies and scan copy before submission of original certificates ( 10<sup>th</sup> Board & Mark Sheet of Graduation or its equivalent) to the office at the time of admission.*

## 10.0 HOSTEL ACCOMMODATION :

Being the Course is completely residential , the Hostel accommodation to all the candidates will be provided .Boarding & fooding charges will have to be borne by the trainees in advance.

The Hostellers shall deposit Hostel Seat Rent and Mess Establishment charges at the time admission only. The Hostellers have to obey the rules & Regulation framed by the College Authority otherwise he/she may be penalized or debarred from the Hostel without any prior notice.
